SCGFC Privacy and Indemnity Policy

Sunshine Coast Game Fishing Club Inc.

Effective: August 25th, 2025

Privacy

1. Purpose and Commitment

Sunshine Coast Game Fishing Club (the Club) is committed to protecting the privacy of its members, sponsors, guests, and participants. We comply with the Information Privacy Act 2009 (Qld) as amended by the Information Privacy and Other Legislation Amendment Act 2023 (IPOLA Act), and the Australian Privacy Principles (APPs) where applicable.

2. Collection of Personal Information

The Club collects personal information necessary for membership, participation, and club operations. This may include:

- Name, address, and contact details
- Date of birth and emergency contacts
- Photographs and video for club promotion (with your consent)
- Other information as required for club activities

We collect information directly from you or your authorised representative, and sometimes from third parties (Gamebase).

3. Use and Disclosure of Personal Information

Your personal information is used to:

- Manage club membership and activities
- Communicate with you about club matters
- Organise events, competitions, and training
- Ensure safety and well-being
- Meet legal, regulatory, and constitutional obligations

We may disclose your information to:

- Sporting bodies, sponsors, and their associations
- Insurers and medical professionals (in emergencies)
- Government agencies, as required by law

We will not use or disclose your personal information for any other purpose without your consent, unless authorised or required by law.

4. Data Security and Retention

The Club takes reasonable steps to protect your personal information from misuse, loss, unauthorised access, modification, or disclosure. The club will not take any responsibility if there are any technical/data breaches, if it is outside of our scope of control, or if they are from an unknown party.

5. Access, Correction, and Data Breaches

You have the right to request access to your personal information and request corrections if it is inaccurate, out-of-date, or incomplete.

Under the IPOLA Act, the Club is required to notify you and the Office of the Information Commissioner, Queensland (OIC), of eligible data breaches that are likely to result in serious harm.

6. Overseas Disclosure

The Club will not disclose your personal information to overseas recipients unless required for club activities, promotion and participation in sporting events, and with your consent, or as permitted by law.

8. Policy Updates

This policy may be updated to reflect changes in legislation or club practices. The latest version will be available on request from the Club Secretary. You will be required to acknowledge and agree to this policy before payment of membership is made and enrollment has been confirmed.

Indemnity

1. Assumption of Risk

Participation in club activities involves inherent risks, including the risk of injury. By participating, members, sponsors, guests, and participants acknowledge and accept these risks. You will be required to acknowledge and agree to this policy before payment of membership is made and enrollment has been confirmed.

2. Indemnity

To the extent permitted by law, members, sponsors, guests, and participants agree to indemnify and hold harmless the Club, its officers, volunteers, and agents from any claims, liabilities, damages, or expenses arising from participation in club activities, except to the extent caused by the negligence or willful misconduct of the Club.

3. Insurance

The Club maintains various insurance coverages as required by relevant sporting bodies and legislation. The Sunshine Coast Game Fishing Club has a public liability insurance policy in place to the value of \$10,000,000.

Members, sponsors, guests, and participants are encouraged to consider their own personal insurance needs to cover themselves at all times.

4. Medical Treatment

In the event of injury or illness, the Club may arrange medical treatment as deemed necessary. Members and participants consent to such treatment and agree to indemnify the Club for any associated costs and any further liability.
